The Council does have concerns about the quality of the workmanship and The Council believes it impacts negatively on the historic core of the Farnhill Conservation area. The Council wish to see some retrospective and ongoing monitoring by Building Regulators and Heritage Regulators given that this property sits squarely within the Farnhill Conservation Area and shares a wall with one of the listed buildings
